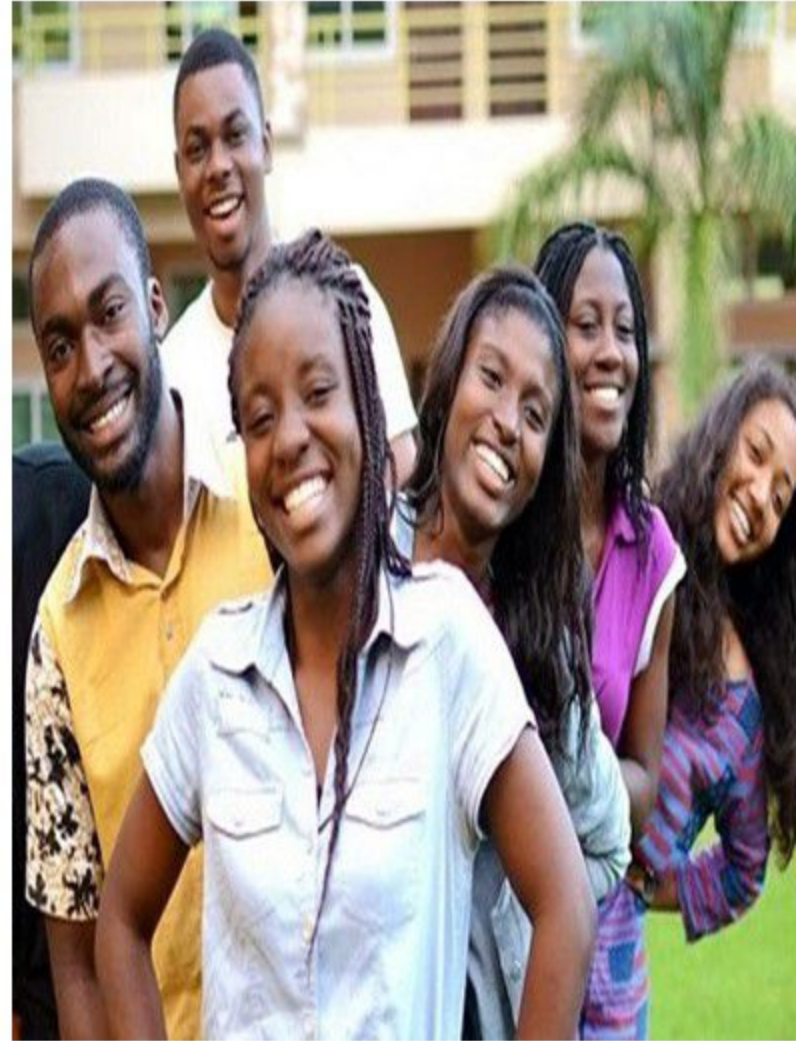

PROVISION OF NEED RESOURCES



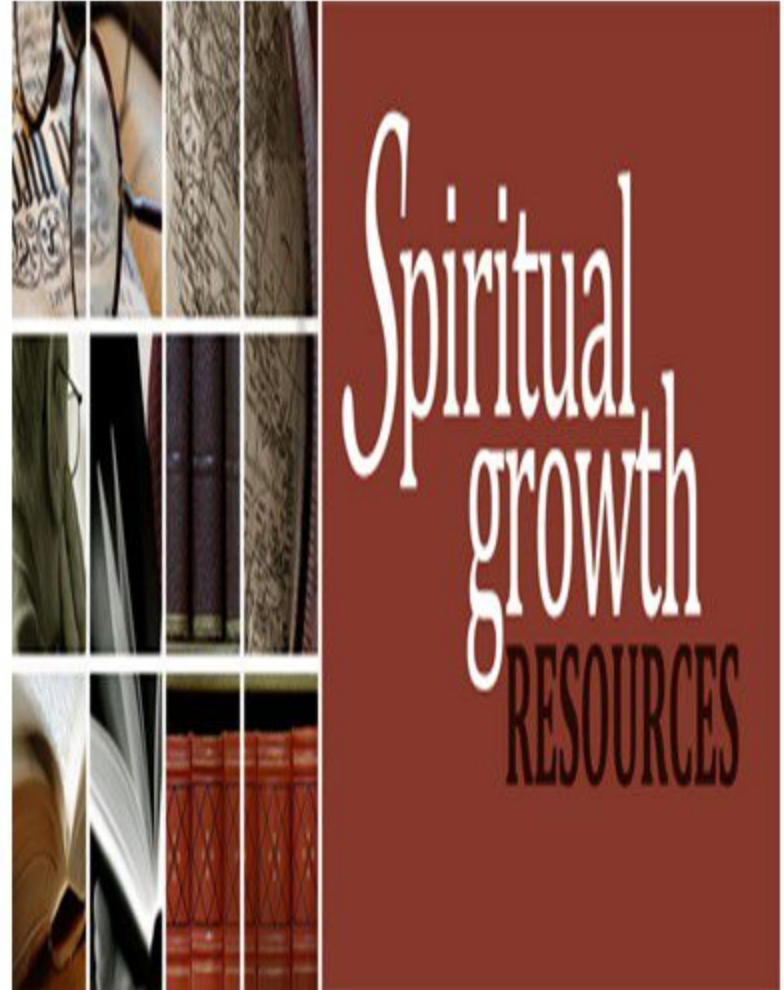
1. YOUTH WORKERS- TS, YOUTH PASTORS & CAMPUS PASTORS
